2. Public Comments / Citizen's Forum

Chair Vonheeder-Leopold opened the Public Comment / Citizen's Forum. There being no speakers, the Public Forum / Citizen's Forum segment was closed.

3. Approve Meeting Minutes of April 26, 2022

Motion: It was m/s by Council Member Sherry Yu / President Sarah Palmer to approve the April 26, 2022 Tri-Valley Water Liaison Committee meeting minutes. The motion passed unanimously.

4. Review of Purpose of Tri-Valley Water Liaison Committee

General Manager Dan McIntyre, DSRSD, commented on a handout that contained information on the purpose and updated work of the Tri-Valley Water Liaison Committee. It was noted this was something that had been requested by the Committee at the previous meeting.

Chair Vonheeder-Leopold questioned if updates should be provided at each Committee meeting, and after discussion, it was determined Committee members would like to receive something in writing only if there was an update.

5. Long-Term Water Supply Projects Status: Sites Reservoir and Los Vaqueros Reservoir

General Manager Valerie Pryor, Zone 7 Water Agency (Zone 7), introduced the item and Associate Engineer Lillian Xie, Zone 7, presented a PowerPoint presentation that provided background and updated information on the Sites Reservoir and Los Vaqueros Reservoir projects.

Zone 7 representatives responded to questions raised by Committee members on these two projects.

Chair Vonheeder-Leopold provided information on plans for a tour of the Los Vaqueros Reservoir project.

6. Actions Taken by Tri-Valley to Address Water Challenges: Recycling and Structural Conservation

General Manager Dan McIntyre, DSRSD, presented this item commenting on how effective the Tri-Valley has been with conservation efforts particularly in using recycled water.

7. Drought and Conservation Roundtable

Chair Vonheeder-Leopold discussed the need to follow Zone 7's lead and have all cities and agencies work together. Committee members discussed water-related State legislation and available websites to obtain information.

Zone 7 representatives commented on the lifting of water restrictions, and amount and cost of water available for the area.

8. Adjournment

Chair Vonheeder-Leopold recognized late attendees to the meeting Tom West (Lawrence Livermore National Laboratory), Osborn Solitei (Zone 7), and Robert Seeley (California Water Service Company).

There being no further business, Chair Vonheeder-Leopold adjourned the meeting at 5:05 p.m. with plans for the next meeting being scheduled for Wednesday, October 25, 2023, at the DSRSD District Office.
