I agree that Zone 7 may visit the premises to verify existing conditions and that the installation has been performed. By virtue of these inspections, I understand that Zone 7 makes no determination with respect to whether materials and equipment are tree of defects, the quality of the workmanship, or the suitability of the premises, materials or equipment for the installation. I also understand that the installation of a Smart Controller may not result in lower water bills. If this Application is approved by Zone 7 and the work proceeds, I agree to defend, indemnify and hold harmless Zone 7, its directors, officers, agents and employees against any and all loss, liability, expense, claims, suits and damages, including attorneys' fees, arising out of or resulting from the installation of a Smart Controller. I authorize my water retailer to make water consumption data available to Zone 7 for the purpose of measuring the success of these programs in conserving water.

TO QUALIFY FOR A REBATE:

- ◆ Applicant must be a customer of a retail water agency within Zone 7's service area (California Water Service Company–Livermore, Dublin San Ramon Services District, City of Livermore, or City of Pleasanton)
- Applicant's water account must be in good standing.
- Multi-family and non-residential customers site must have a dedicated potable water irrigation meter(s) or landscape sub- meter(s) to measure all landscape water use.
- Site must have history past one (1) year of water use.
- Applicant must select, purchase and install a Smart Irrigation Controller from the Zone 7 Qualifying Irrigation Controller List
 of approved controllers. All areas on multi-family and non-residential customers site must be converted to Smart Irrigation
 Controller(s) to receive a rebate.
- Installation must be complete before applying for rebate.
- Rebate application must be postmarked within 90 days of smart controller purchase date.
- Controller must remain on-site for a minimum of two (2) years.

Funding is limited. Rebates are one time only per site, and will be provided on a first-come, first-served basis. Applications and receipts must be postmarked, emailed, or faxed within 90 days of purchasing Smart Controller. You have two options for submitting your rebate application (electronic submittal preferred):

1. Complete the electronic Smart Controller rebate application available at www.zone7water.com. Scan your original sales receipt and water account bill and save as PDF files. Email a copy of application and the scanned sales receipt and water bill to: rebates@zone7water.com. If unable to send electronic attachments, you may fax a copy of your electronic application, the original sales receipt and water account bill to 925- 454- 5726 within 24 hours of submitting the electronic application submittal.

PROJECT INFORMATION:

- Single-family residences must have a minimum of 500 square feet of irrigated lawn with at least 4 stations.
- All irrigated areas must be converted to a Smart Controller. Special conditions may apply.
- Only one Smart Controller per single-family property will be rebated. Non-residential properties will be individually evaluated.

REBATE INFORMATION:

- The Smart Irrigation Controller you purchase must be off the Qualifying Controller List found at www.zone7water.com.
- Sales tax, installation, programming costs, and other fees are not inlouded in rebate.
