I, the undersigned, understand that this is a one-time pilot program, limited to first-come/first-served, that rebates are given only for projects which applications are approved in advance of purchase and installation, and that Zone 7 Water Agency (Zone 7) is entitled to deny any application that does not meet program requirements. I am volunteering to participate in the Zone 7 Garden by Number Rebate Program. I have selected a garden box, a garden shape, and a pickup location. I understand that I will self-certify as described in the program Garden by Number instructions. I agree that all work performed will comply with applicable state and local laws, ordinances, and regulations. I agree that Zone 7 staff and the water retailers staff participating in this program may visit the premises and verify existing conditions and that the work has been performed. By virtue of these inspections, I understand that Zone 7 makes no determination with respect to whether the materials and equipment are free of defects, the quality of workmanship, or the suitability of the premises, material or equipment for this installation. I also understand that the deletion of irrigation equipment and landscape materials may not result in lower water bills. If this application is approved by Zone 7 and the work proceeds, I agree to defend indemnify and hold harmless Zone 7, its directors, officers, agents, participating water retailers, and all employees against any and all loss, liability, expense, claims, suits and damages, including attorneys fees arising out of or resulting from the installation of irrigation equipment and landscape material. I authorize my water retailer to make water consumption data available to Zone 7 for the purpose of measuring the success of this program and conserving water. I agree to pre-and/or post-inspections upon request. I have read, understand, and agree to the terms and conditions of this rebate program.
