#### TO QUALIFY FOR A REBATE:

- Applicant must receive their water service from either Dublin San Ramon Services District, City of Livermore, or City of Pleasanton).

  Properties that receive their water service from California Water Service (Cal Water) do not qualify for this rebate.
- Applicant's water account must be in good standing.
- Commerical sites must have a dedicated potable water irrigation meter(s) or landscape sub- meter(s) to measure all landscape water use.
- Applicant must select, purchase and install a Smart Irrigation Controller from the *EPA WaterSense Weather-basedIrrigationController List* of approved controllers. All areas on site must be converted to Smart Irrigation Controller(s) to receive a rebate.
- Installation must be complete before applying for rebate. You must provide a picture of the installed controller and a Screenshot(s) of the controller settings.
- Rebate application must be postmarked within 60 days of purchase date.
- Controller must remain on- site for a minimum of two (2) years.

Funding is limited. Rebates are one-time-only per site, and will be provided on a first-come, first served basis.

- One Smart Controller per water account.
- Multi-family and Commercial customers must have a dedicated irrigation meter.
- All irrigated areas must be converted to a new Smart Controller.

- 1. Complete your application
- 2. Attached a copy of your receipt
- 3. Include a picture of your installed controller and a screen-shot(s) of your controller programming settings.
- 4. Submit the required documentation by email or by regualr mail.

#### REBATE INFORMATION:

- The Smart Irrigation Controller you purchase must be from the EPA WaterSense Weather-based Irrigation Controller Product List. The List can be found on the EPA Watersense website.
- Sales tax, installation, programming costs, and other fees are not rebated.
