## **ADVERTISEMENT FOR BIDS**

**1. NOTICE.** The ALAMEDA COUNTY FLOOD CONTROL and WATER CONSERVATION DISTRICT, acting by and through its ZONE 7 WATER AGENCY ("District") hereby gives notice that it will accept Bids for construction of the following public work:

2. BID SUBMISSION. District will receive sealed Bids no later than 2:00pm on Thursday, March 24, 2022, as determined by District staff by using www.time.gov. Due to Alameda County Health Orders for limiting the spread of COVID-19, the Bid Opening will take place virtually only by Zoom webinar. District will accept bids at the front desk of the District's Main Office at 100 N. Canyons Parkway, Livermore, CA 94551. The Bid Box will be available to deposit bids starting at 8:00am on the day of the Bid Opening and will be removed promptly at 2:00pm. The Bid Box will be monitored by District staff. The Zoom webinar link for the Bid Opening will be posted on District's website (www.zone7water.com) and may also be obtained by contacting the Project Engineer by email. Bids will be in accordance with procedures set forth in Document 00200 (Instructions to Bidders) and as modified in Document 00800 (Supplementary Conditions – Division 0).

**4. DESCRIPTION OF THE WORK.** The Work under "Arroyo Mocho Medeiros Reach Floodplain Reconnection Project" consists of lowering a portion of the Arroyo Mocho asphalt bike trail and embankment, improving existing dirt trails with aggregate base rock and removing invasive plant species within the Medeiros Reach of Arroyo Mocho between Arroyo Road and Holmes Street in Livermore. The Bidding Documents contain the full description of the Work. The Engineer's estimate for this project is \$540,000.

- **5. CONTRACT TIME.** The Contract Time shall be the Days from the District's Notice to Proceed (anticipated to be June 2022) to the Contractor to the Final Completion date of October 15, 2023. Substantial Completion date is October 15, 2022.
- 6. REQUIRED CONTRACTOR'S LICENSE(S). Each bidder is required to have a valid and current California Class A General Engineering license to bid this Contract. Joint ventures must secure a joint venture license prior to award of this Contract. Removal, handling, and/or disposal of hazardous materials may by law require hazardous substance removal certification by the Contractor's State License Board.

The pesticide applicator (Contractor or Sub-Contractor) must possess a current and valid Qualified Applicator License (QAL) with an Aquatic Pest Control category issued by the California Department of Pesticide Regulation.

**PUBLIC WORKS CONTRACTOR REGISTRATION.** A contractor or subcontractor shall not be qualified to bid on, be listed in a bid proposal, subject to the requirement of Section 4104 of the Public Contract Code, or engage in the performance of any contract for public work, as defined in this chapter [1770-1784 Labor Code], unless currently registered and qualified to perform public work pursuant to Section 7029.1 of the Business and Professional Code or by Section 10164 or 20103.5 of the Public Contract Code, provided the contractor is registered to perform public work pursuant to Section 1725.5 at the time the contract is awarded.

**REQUIRED MINIMUM QUALIFICATIONS.** A Contractor or subcontractor shall have the minimum qualifications to perform the work as described in Section 00450 (Statement of Qualifications for Construction Work).

- **7. PREVAILING WAGE LAWS.** The successful Bidder must comply with all prevailing wage laws applicable to the Project, and related requirements contained in the Contract Documents. Pursuant to applicable provisions of the Labor Code, the District has implemented and shall enforce a Labor Compliance Program (LCP) for the Work. The successful Bidder shall be required to comply with all the requirements of the District's LCP and applicable provisions of the California Labor Code. In bidding on the Work, it shall be each Bidder's responsibility to evaluate the cost of complying with the District's LCP. Bidders shall include all costs of compliance with specified requirements in their bids.
- **8. MANDATORY PRE-BID MEETING AND SITE VISIT**. Due to Alameda County Health Orders to limit the spread of COVID-19, District will not conduct an in-person Pre-Bid Meeting. Instead, the District will conduct a Virtual Mandatory Pre-Bid

The Zoom webinar link for the Bid Opening will be posted on the District's website at <u>www.zone7water.com</u> and may also be obtained by contacting the Project Engineer by email. Any Bidder wishing to investigate conditions at the Site must schedule such a visit with the District in accordance with Document 00200 (Instructions to Bidders). Attendance at the mandatory meeting will be taken. If a Bidder fails to attend the Mandatory Pre-Bid Meeting as required, the District reserves the right to reject the Bid as non-responsive. Attendance to the Pre-Bid Site Visit is mandatory. Mandatory Pre-Bid Site Visits will be scheduled for 1:00pm on **March 3, 2022** and a second session at 1:00pm on **March 4, 2022**. Six (6) Bidders will be able to attend each session. Contractor must schedule which session, if any, they would like to attend in advance with the Project Engineer, spots are available on a first come, first serve basis. District will add site visits if there are more contractors interested than there are slots available.

- 9. SUBSTITUTION OF SECURITIES District will permit successful Bidder to substitute securities for retention monies withheld to ensure performance of Contract, as set forth in Document 00680 (Escrow Agreement for Security Deposits in Lieu of Retention), in accordance with California Public Contract Code, Section 22300. By this reference, Document 00680 (Escrow Agreement for Security Deposits in Lieu of Retention) is incorporated in full in this Document 00100.
- **10.PROCUREMENT OF BIDDING DOCUMENTS.** Due to COVID-19, no bid documents are available at the District's offices for viewing or purchase. Bidding Documents are located online on the District's website at <u>www.zone7water.com</u> where Bidders may download copies for no fee. Bidders must complete the web form to download plans and specs directly from the Zone 7 website to be put on the Planholders' List. Any addenda will be posted on the District's website and will be sent by email to those on the Planholders' List. If a Bidder fails to be put on the Planholders' List as required, the District reserves the right to reject the Bid as non-responsive.
- **11.BID PREPARATION COST.** Bidders are solely responsible for the cost of preparing their Bids.
- **12.RESERVATION OF RIGHTS.** District specifically reserves the right, in its sole discretion, to reject any or all Bids, or re-bid, or to waive inconsequential deviations from Bid requirements not involving time, price, or quality of the Work.
