**ADVERTISEMENT FOR BIDS**

- 1. NOTICE.** The ALAMEDA COUNTY FLOOD CONTROL and WATER CONSERVATION DISTRICT, acting by and through its ZONE 7 WATER AGENCY ("District") hereby gives notice that it will accept Bids for construction of the following public work:

- 2. BID SUBMISSION.** District will receive sealed Bids no later than **2:00pm on Thursday, April 14, 2022**, as determined by District staff by using [www.time.gov](http://www.time.gov). Due to Alameda County Health Orders for limiting the spread of COVID-19, the Bid Opening will take place virtually only by Zoom webinar. District will set up a Bid Box at the front desk of District's Main Office at 100 N. Canyons Parkway, Livermore, CA 94551. The Bid Box will be available to deposit bids starting at 12:30 pm on the day of the Bid Opening and will be removed promptly at 2:00pm. The Bid Box will be monitored by District staff. The Zoom webinar link for the Bid Opening will be posted on District's website ([www.zone7water.com](http://www.zone7water.com)) and may also be obtained by contacting the Project Engineer by phone or email. Bids will be opened and read aloud at the virtual Zoom webinar. The Bid opening will be in accordance with procedures set forth in Document 00200 (Instructions to Bidders) and as modified in Document 00800 (Supplementary Conditions – Division 0).

**4. DESCRIPTION OF THE WORK.** The Work consists of the supply of fully operated and maintained construction equipment and the furnishing of labor and material to implement engineered repairs and upgrades to flood control facilities on an as-needed or emergency basis. The Work may include, but is not limited to, the following major end-items:

1. Installation and maintenance of a water diversion system for flows in a live stream, creek, or flood control channel in compliance with regulatory permits
2. Installation of riprap embankment and/or riprap repairs for bank slides in a live stream, creek, or flood control channel
3. Installation of geosynthetic materials to structurally support access roads or channel embankments in a live stream, creek, or flood control channel
4. Construction and / or repair of riprap structures in a live stream, creek, or flood control channel, such as rock veins, rock spurs, or rock grade controls
5. Construction of biotechnical stabilization in live stream, creek, or flood control channel embankments like MSE walls, BioD Blocks, and/or log crib walls
6. Removal of accumulated sediment from a live stream, creek, or flood control channel
7. Construction of access road improvements adjacent to flowing water body, like a live stream, creek, or flood control channel, or regulated environmentally sensitive areas, including road surfacing with various materials, concrete V-ditches, drain inlets, culverts, and outfalls
8. Construction and / or repair of concrete structures in a live stream, creek, or flood control channel, such as panels, outfalls, grade controls, confluence structures, cut-off walls, and utility crossings
9. Removal of miscellaneous concrete and / or rock structures from a live stream, creek, or flood control channel
10. Excavation and repair of major storm drain pipes
11. Construction of new or replacement facility access points, storage areas, and staging locations
12. Incidental items to facilitate major end-items, such as 1) procurement, delivery, staging, and maintenance of materials and equipment, 2) tree trimming and removal, 3) hydroseeding, 4) applications for appropriate traffic control permits, 5) installation of appropriate project signage and 6) compliance with all and implementation of permit requirements
13. Miscellaneous work as directed by the District Representative

The District anticipates that the majority of the Work will be performed during work hours defined in Section 01100 (Summary of Work). However, the Contractor shall be available to perform District's Work on twenty-four hours per day/seven days per week (24/7) basis for emergency Work. When it is determined to be an emergency Work by the District Representative, Contractor must mobilize work force and equipment and respond to sites within two (2) hours of District notification, to perform the Work

specified by District. For non-emergency Work, Contractor is required to mobilize and respond to District's request no more than two (2) calendar weeks upon notification. In order to facilitate a quick deployment of equipment and work force in an emergency, the District requires that the BIDDER shall have an operation yard located within a twenty-five (25) mile radius of the Zone 7 North Canyons Parkway office in Livermore. Failure to comply with this condition will result in disqualification of bids.

The contract is in the amount not to exceed \$900,000 per year. However, bid items may be greatly increased or decreased or reduced to zero. The increase or decrease of these amounts as compared with those set forth in the Document 00520 (Agreement) will not constitute a basis for claim by the Contractor for extra payment or damages or for anticipated profit. All work will be measured for payment on a time and material basis at the hourly rates and markup percentages set forth in the Document 00520 (Agreement).

- 5. CONTRACT TIME.** The duration of the Contract shall be from July 1, 2022 through June 30, 2023. During this period, the Contractor shall be available to perform Work on an on-call basis as directed by the District Representative. The contract may be extended for one (1) additional one-year period at the District's sole discretion. Terms of Contract Time are set forth in Document 00700 (General Conditions). Contractor shall commence Work on the date established in the Notice to Proceed. If the District extends the Contract for an additional one year period, the Contract Bonds and Insurance (Item 1), the unit prices from Items 2 through 17 for equipment and labor and Item 22 for All Work of Contract Documents other than Work separately provided for under other Bid items in the schedule of Bid Prices will be indexed to the most current Engineering News Record Construction Cost Index as published by McGraw Hill Publishing Company, in effect at the time of contract extension. The indexing for each additional one-year period, if any, shall occur once on the first day of the extension, and will remain in effect for the remainder of each additional one-year period. The Construction Cost Index for March 2022 for San Francisco shall be used as the base in comparison for updating the Bid prices for reimbursement purposes for the additional periods, if any.

- 6. REQUIRED CONTRACTOR'S LICENSE(S).** Each bidder is required to have a valid and current **California Class A – General Engineering** license to bid this Contract. Joint ventures must secure a joint venture license prior to award of this Contract. Removal, handling, and/or disposal of hazardous materials may by law require hazardous substance removal certification by the Contractor's State License Board.

**PUBLIC WORKS CONTRACTOR REGISTRATION.** A contractor or subcontractor shall not be qualified to bid on, be listed in a bid proposal, subject to the requirement of Section 4104 of the Public Contract Code, or engage in the performance of any contract for public work, as defined in this chapter [1770-1784 Labor Code], unless currently

registered and qualified to perform public work pursuant to Section 7029.1 of the Business and Professional Code or by Section 10164 or 20103.5 of the Public Contract Code, provided the contractor is registered to perform public work pursuant to Section 1725.5 at the time the contract is awarded.

**REQUIRED MINIMUM QUALIFICATIONS.** A Contractor or subcontractor shall have the minimum qualifications to perform the work as described in Section 00450 (Statement of Qualifications for Construction Work).

7. **PREVAILING WAGE LAWS.** The successful Bidder must comply with all prevailing wage laws applicable to the Project, and related requirements contained in the Contract Documents. Pursuant to applicable provisions of the Labor Code, the District has implemented and shall enforce a Labor Compliance Program (LCP) for the Work. The successful Bidder shall be required to comply with all the requirements of the District's LCP and applicable provisions of the California Labor Code. In bidding on the Work, it shall be each Bidder's responsibility to evaluate the cost of complying with the District's LCP. Bidders shall include all costs of compliance with specified requirements in their bids.
8. **MANDATORY PRE-BID MEETING AND OPTIONAL SITE VISIT.** Due to Alameda County Health Orders to limit the spread of COVID-19, District will not conduct an in-person Pre-Bid Meeting. Instead, the District will conduct a Virtual Mandatory Pre-Bid Meeting at **10:00am on Wednesday, March 30, 2022** using Zoom webinar. The Zoom webinar link for the Bid Opening will be posted on the District's website at [www.zone7water.com](http://www.zone7water.com) and may also be obtained by contacting the Project Engineer by email. Any Bidder wishing to investigate conditions at the Site must schedule such a visit with the District in accordance with Document 00200 (Instructions to Bidders). Attendance at the mandatory meeting will be taken. If a Bidder fails to attend the Mandatory Pre-Bid Meeting as required, the District reserves the right to reject the Bid as non-responsive. Attendance to the Pre-Bid Site Visit is optional. Optional Pre-Bid Site Visits will be scheduled for 1:00pm on **March 30, 2022** and a second session at 9:00am on **March 31, 2022**. Six (6) Bidders will be able to attend each session. Contractor must schedule which session, if any, they would like to attend in advance with the Project Engineer, spots are available on a first come, first serve basis. District will consider adding site visits if there are more contractors interested than there are slots available.

10. **PROCUREMENT OF BIDDING DOCUMENTS.** Due to COVID-19, no bid documents are available at the District's offices for viewing or purchase. Bidding Documents are located online on the District's website at [www.zone7water.com](http://www.zone7water.com) where Bidders may download copies for no fee. Bidders must complete the web form to download plans and specs directly from the Zone 7 website to be put on the Planholders' List. Any

addenda will be posted on the District's website and will be sent by email to those on the Planholders' List. If a Bidder fails to be put on the Planholders' List as required, the District reserves the right to reject the Bid as non-responsive.

- 11. BID PREPARATION COST.** Bidders are solely responsible for the cost of preparing their Bids.
- 12. RESERVATION OF RIGHTS.** District specifically reserves the right, in its sole discretion, to reject any or all Bids, or re-bid, or to waive inconsequential deviations from Bid requirements not involving time, price, or quality of the Work.
