INTRODUCED BY DIRECTOR RAMIREZ HOLMES SECONDED BY DIRECTOR GAMBS

Adoption of Calendar Year 2023 Untreated Water Rates

WHEREAS, the proposed action is in support of Strategic Plan Goal G - Fiscal Responsibility: Operate the Zone 7 Water Agency (the "Agency") in a fiscally responsible manner. In carrying out these fiscal responsibilities, the Agency sets rates and fees to recover cost of service; and

WHEREAS, the Agency contracted with Raftelis to determine untreated water rates for Calendar Year (CY) 2023 using the rate methodology and rate components approved in Board Resolution No. 21-77; and

WHEREAS, in order to minimize rate impacts to untreated water customers, the untreated water rate for CY 2023 shall be calculated using a three-average of prior year water supply costs of \$8 million; and

WHEREAS, should water supply cost for CY 2023 be more or less than \$8 million, a rate reconciliation charge or credit shall be applied to future untreated water rates as directed by the Board; and

WHEREAS, a reconciliation charge of \$164 per acre-foot for CY 2021 has been determined, and \$36 per acre-foot of the total amount will be applied to the CY 2023 untreated rate and the remaining balance of \$128 per acre-foot will be applied to future untreated water rates as directed by the Board.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of Zone 7 of the Alameda County Flood Control and Water Conservation District, adopt the following rate schedule for Untreated Water Service, Temporary Untreated Water Service, and Non-Scheduled Untreated Water Services, be adopted:

FIRST, for Untreated Water Service, a delivery charge of \$255 per acre-foot for all metered water delivered to each customer per month which includes a CY 2021 reconciliation charge of \$36 per acre-foot; and

SECOND, for Temporary Untreated Water Service, an initial service establishment charge of \$125 per turnout for each new direct connection to the Zone system or a system supplying the Zone system; and

A monthly service charge of \$21 per turnout; and

A delivery charge of \$1,028 per acre-foot for all water delivered monthly based on total meter readings or as may be otherwise determined by the Agency; and

THIRD, for Non-Scheduled Untreated Water Service, a delivery charge of \$1,028 per acre-foot for water delivered to each customer per month; and

BE IT FURTHER RESOLVED, that said rate schedule for Untreated Water Service, Temporary Untreated Water Service, and Non-Scheduled Untreated Water Service shall be effective as of January 1, 2023, and shall end on the next effective date for such water rates adopted by the Board.
